

The 6<sup>th</sup> meeting the River Rejuvenation Committee (RRC), constituted by the Government of Uttarakhand vide its Office Order ref. no. 976/X-3-18-15(96)2019 dated 05.12.2019 was held on dated 24.06.2019 under the Chairmanship of the Principal Secretary, Forest and Environment, Govt. of Uttarakhand. - 2. Principal Secretary welcomed all members of River Rejuvenation Committee and other invitees. Member Secretary, UEPPCB briefed about the letter of the Central Pollution Control Board issued on 18.06.2019 and also mentioned shortcoming of action plans mentioned in the said letter. It was also informed that in view of shortcoming/deficiencies reported by the Central pollution Control Board, action plans for rejuvenation of priority-I & II stretches i.e. rivers Bhela (Kashipur to Rajpura Tanda), Dhela (Kashipur to Garhuwala, Thakurdwara), Suswa (Mothrawala to Raiwala) and Kichha (along the Kichha town) rivers have been prepared. Draft action plans have placed before the RRC for kind consideration.
- 3. Presentations on gap analysis of sewage management, solid waste management, industrial effluent management etc. along with proposed action plan for rejuvenation of each polluted river stretch have been made before the RRC. RRC discussed proposed activities in detail and approved action plans of all 4-polluted river stretches of priority-I&II and decided that the Member Secretary, UEPPCB will forward approved action plans to the Central Pollution Control Board, Delhi for further approval.
- 4. It was also informed that meeting of Task Team of CPCB on said matter is scheduled on 16.07.2019 at CPCB, Delhi. RRC also directed



that he UEPPCB will present the action plans of all 4-Polluted river stretches before the Task Team at CPCB.
