In light of the above, we pass the following directions:-

- 1. The State Government of Uttarakhand and the State Pollution Control Board also shall abide by their statements. The State Government shall provide all assistance to the Uttarakhand State Pollution Control Board for closure of these Hot-mix Plants as directed in the list, particularly those which have already been ordered to be closed and/or to the 35 Hot-mix Plants to whom orders have already been passed.
- Compliance report in this regard should be submitted within two weeks from today before the Tribunal.
- 3. The applicant may furnish a list of all the Hot-mix Plants which are operating in the State of Uttarakhand, but have not been specifically mentioned in the list filed by the State before the Tribunal. The list will be furnished within one week from today. If such list is furnished within one week whichever the Hot-mix Plants according to the applicant are operating without consent or violating the consent granted to them. The State shall take appropriate action in accordance with law including the closure of those non-compliant Hot-mix Plants.

We also direct the State Government and the Uttarakhand Pollution Control Board to issue general directions to all the district authorities to prepare a list of Hot-mix Plants which are operating under their jurisdiction. That list will be circulated to the

Uttarakhand Pollution Control Board for appropriate action as above recoded in accordance with law, expeditiously.

The compliance report shall be filed before the Tribunal within four weeks from today. As and when the report is filed, the same shall be registered and numbered by the Registry and put up for direction before the Tribunal.

With the above directions M.A. No. 544 of 2017 stands disposed of. No order as to cost.
