The work is estimated to Cost Rs. 300000/- per year. This estimate, however, is given merely as a rough guide. Intending tenderer is eligible to submit the bid provided he has definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed similar works of magnitude specified below:-

Criteria of eligibility

Three similar works each of value (CAMC for a year) not less than Rs. 112,000/- or two similar work each of value not less than Rs. 180000/- or one similar work of value not less than Rs. 2,24000/- in last 5 years ending last day of the month previous to the one in which the tenders are invited.

Similar works means "Comprehensive Annual Maintenance of Lifts or S.I.T.C. of Lifts". The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to lastdate of receipt of tenders.

An Agreement shall be drawn with the successful bidders.

The bid document consisting of plans if any, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents except Standard General Conditions of Contract.

Earnest Money in the form of Demand Draft or Pay order or Bankers Cheque or Deposit at Call Receipt or Fixed Deposit Receipt (drawn in favour of Uttarakhad Pollution Control Board shall be submitted along with bid The contractor whose bid is accepted will be required to furnish performance guarantee of 3% (Three Percent) within 15 days of the issue of award letter.

Guarantee will be submitted on yearly basis against the amount of CAMC for the respective year.

This guarantee shall be in the form of Government Securities or Guarantee Bonds of any Scheduled. In case the contractor fails to deposit the said performance guarantee within the period the Earnest Money deposited by the contractor shall be forfeited automatically without any notice to the contractor. The earnest money

deposited shall be returned after receiving the aforesaid performance guarantee.
The contractor whose bid is accepted will also be required to furnish either copy of applicable licenses/registration or proof of applying for obtaining labour licenses, registration with EPFO, ESIC and BOCW welfare Board including Provident Fund Code No. if applicable and also ensure the compliance of aforesaid provisions by the sub-contractors, if any engaged by the contractor for the said work within the period specified in schedule F.

Intending bidders are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their bids as to the nature of work and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their bid. A bidder shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. The bidder shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a bid by a bidder implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of conditions and rates at which stores, tools and plant, etc. will be issued to him by the Government and local conditions and other factors having a bearing on the execution of the work.

The competent authority on behalf of the Director of Uttarakhad Pollution Control Board does not bind itself to accept the lowest or any other bid and reserves to itself the authority to reject any or all the bids received without the assignment of any reason. All bids in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the tenderer shall be summarily rejected.

Canvassing whether directly or indirectly, in connection with bidders is strictly prohibited and the tenders submitted by the contractors who resort to canvassing will be liable to rejection. The competent authority on behalf of the MS Uttarakhad Pollution Control Board reserves to himself the right of accepting the whole or any part of the tender and the tenderer shall be bound to perform the same at the rate quoted.

The bid for the works shall remain open for acceptance for a period of 90 (Ninety) days from the date of opening of Financial bids.
