During the meeting presentation on the EOI document was made by Board Officials. Various aspects were discussed with the representatives present in the meeting and also the comments were also discussed received by email from Gujarat Environment Management Institute, Gandhinagar and from Ultimate Strategic Solution (USS LLP). Considering to all comments following decisions are taken: -

- It is clarified that in the scope of work -Inventorization of HCFs will be carried out only HCFs
 as per definition of occupier under Bio Medical Waste Management and Handling Rules and
 to be inventorised as per Appendix-1. However, Ayurvedic HCFS, Homeopathic HCFs,
 Unani HCFs, first aid centres at Schools, hostels, chemists, medical supplier shops are
 excluded.
- 2. It is also clarified that the Labs accrediated from NABL, and NGOs, Foundations Trusts engaged in research activities are allowed in bidding process.
- 3. It is also clarified that, if any HCF is not sign the appendix during the field survey, in such case it is to be clearly mentioned that the HCF is denied to sign. Photograph with Lat-Long to be enclosed in such case separately.
- 4. In para C.5.7, Notice Time for presentation from the Bidder to be replaced with 10 days in place of short notice.
- 5. **Fitrst line of Para No. C.5.8** "The application is not received as per the condition specified in Clause 3.3.4" is considered as **omitted**.
- 6. In the paras C.5.9 (C) time line for submission of dully filled questionnaires along with data analysis in excel format is modified as 180 days in place of 120 days.

 - For Other Institutions like NGOs, autonomous bodies etc.:- 25% Advance, 50% after submission of draft report and 25% after approval of final report.
 - e) Selected organisation has to submit Earnest money of 5% of the total study cost.
- 9. In the Para C.5.19, the line "The Institution should not any where in the EOI quote or mention the rates/charges. This would lead to disqualification" may be considered as omitted:
